# Release Form

## This form must be signed and dated by all persons attending the Empire Open Dance Festival

The undersigned, being fully cognizant of the risks inherent in ballroom dancing and exhibitions, shall hereby:

1. Assume all risks of bodily injury (including death) and property damage inherent in attending this event.
2. Release and hold harmless Empire Open Dance Festival; Empire Open Dance Festival, Inc.; Donnie Burns MBE, Heidi Burns, Sergey Kolmykov, Esq. and/or the National Dance Council of America, Inc. from all claims, liabilities, obligations, promises, agreements, disputes, demands, damages, causes of action of any nature and kind, known or unknown, to me, my successors, employees, my personal representatives, assigns, partners, agents, heirs, and next of kin, and against any claim or cause of action which I, or anyone claiming by, through or under me, has or ever had or may at any time in the future have against those hereby released, arising out of bodily injury (including death) or damage, loss or theft of articles left in changing rooms, ballrooms, or hotel rooms, suffered by me while attending this event.

Consent to the use and release of his/her name and likeness to be used in photographs, television filming and recording of the event used in connection with the television broadcast, exhibition, distribution or promotion of the event in any manner and by any means, now or in the future, by Empire Open Dance Festival; Empire Open Dance Festival, Inc.; Donnie Burns MBE, Heidi Burns, Serge Kolmykov; or the National Dance Council of America, Inc.\*
